1. Customs Delivery Order Charges:
(Inclusive Electronic Processing Customs Date)
 - A. General Cargo per AWB: € 48,25
 - B. Change Agent: € 17,50

2. Storage Charges:
Per 100 kg and per day – Applicable volume ratio 1/6
 - A. General Cargo:
After the free storage period, the following charges are applicable, per 100 kg, per day:
 - During the first five days € 6,00
 - After five days € 10,00
 - Minimum charges € 33,50
 - Free storage period: 24 hours
 - B. Perishables:
Veterinary control fee as per official fee of the federal agency
 - Per 100 kg, per day € 6,50
 - Minimum per shipment € 47,50
 - Free storage period: the day of arrival
 - C. Valuables:
 - **As per external security company rates** (plus 10% administration charges)
 - Transport as per other services (*point 8*)
 - D. Live Animals:
Veterinary control fee as per official fee of the federal agency
 - Per 100 kg, per day € 40,00
 - Minimum per shipment € 88,00
 - Use of infrastructure / per shipment € 100,00
 - Transport as per other services (*point 8*)
 - Free storage period: 24 hours – as from 08h00 the day following the day of arrival

Note: The free storage period of 24 hours:
 - will start as from 08h00 the day after arrival, for Cargo arriving after 20h00;
 - will be prolonged by 24 hours, in case a Sunday and/or Public Holiday falls in the free 24 hours, or immediately follows the free 24 hours.

D. Live Animals:

Veterinary control fee as per official fee of the federal agency

- Per 100 kg, per day € 40,00

- Minimum per shipment € 88,00

- Use of infrastructure / per shipment € 100,00

- Transport as per other services (*point 8*)

- Free storage period: 24 hours – as from
08h00 the day following the day of arrival

Note: Maximum storage period is 2 weeks

After 2 weeks, the goods will be returned to the Shipper, at his own expenses

3. Dangerous Goods Shipment Charges:

Dangerous Goods have to be accompanied by a Shipper's Certificate,
in accordance with IATA Dangerous Goods Regulations

A. Per Shipper's Declaration – maximum 1 UN number: € 46,00

B. Per additional UN number: € 5,50

C. Re-check Fee: € 39,50

D. Dangerous Goods Fee / Dry Ice: € 20,00

E. Dangerous Goods Fee / Dry Ice Re-check: € 10,00
